Ohio Natural Resources Hall of Fame awards program has a proud history. Established in 1966, the Hall of Fame is Ohio's top honor for individuals – past and present – who have made significant contributions to preserving and protecting the state's water, soil, woodlands, wildlife and mineral resources.

To date, 150 individuals have been accorded this honor. Previous Hall of Fame honorees include the legendary Johnny Appleseed, Ohio-born explorer John Wesley Powell, botanist Lucy Braun, conservationist and author Louis Bromfield, as well as farming conservation advocate Bob Evans.

Many stewards have devoted much of their life to safeguarding the beauty of Ohio's natural landscape for today's enjoyment and for future generations. These individuals include farmers, educators, birders, biologists, lawmakers, activists, foresters, geologists, anglers and hunters.

Submission Deadline: September 3, 2010

The Ohio Natural Resources Hall of Fame recognizes outstanding contributions by individuals in conserving the state's land, water, forests, wildlife and mineral resources.

CRITERIA

1. Nominations may be made by any individual or organization in Ohio.
2. Nominee must have been born in Ohio or have made a significant contribution specifically to Ohio's natural resources.
3. Nominee's contribution must be a product of a lifetime devoted to furthering the best interests of natural resources management, conservation or preservation. Special consideration will be given to those who have shown creativity and innovation in their contributions.

INSTRUCTIONS

1. Review awards list to be sure your nominee hasn't already been honored; however, previous nominations may be resubmitted.
2. Please complete this nomination form. If more space is needed, an additional 8-1/2" x 11" sheet of paper may be attached. REMEMBER, provide as much information and detail as you can. This form is the only information used to determine inductees into the Hall of Fame.
3. Please do not send letters of recommendation.
4. Nomination forms will not be returned; please retain a copy for your files.
5. All nominations must be postmarked on or before September 3, 2010.
6. This form may be copied if you need additional sets. Nominations can also be made online at ohiodnr.com.
